# West Coast Eagles - Qantas Flights

# 1) Bookings

- a) All prices quoted by Travel & Sports Australia are in Australian Dollars and are inclusive of Goods & Services Tax (GST).
- b) Please ensure all names entered when making an online booking match the correct spelling of all first names and surnames of your complete travelling party, as per their traveller's passport, driver's license or photographic identification. Failure to provide correct spelling as per your passport, driver's license or photographic identification will incur amendment fees and in some instances may be refused entry and/or boarding on airline carriers.
- c) All reservations are subject to availability at the time of booking. Your deposit will secure your reservation however your booking will only be fully confirmed upon receipt of final payment.
- d) Prices may vary due to third party suppliers increasing cost, taxes etc. and these shall be the responsibility of the traveller prior to final payment. Travel & Sports Australia will cover these additional charges if the traveller has paid in full for their package.
- e) On all bookings where more than one passenger is travelling the person making the booking on behalf of his/her travelling companions will be deemed to have accepted the booking terms and conditions on behalf of all of his/her travelling companions.
- f) IMPORTANT NOTE: This specific offer does not include seats and/or hospitality for the 2015 Toyota AFL Grand Final.
- g) IMPORTANT NOTE: This specific offer *does not* include accommodation or transfers.
- h) All packages are subject to a Travel and Sports Australia administration fee of \$20.00 per booking.

## 2) Payment Type – Credit Card ONLY for this specific event.

- a) Travel & Sports Australia accept the following forms of payment:

- b) All credit card payments will incur a 2% surcharge
- c) All credit card payments must be accompanied by a signed and dated Registration and Payment Authority form, authorising Travel and Sports Australia to charge the nominated credit card.

## 3) Schedule of Payments

## a) Deposit:

- i) An \$80.00 per person deposit is required upon registration with one applicable condition.
  - (1) Non-refundable if the West Coast Eagles **don't qualify** for the 2015 Toyota AFL Grand Final and your reservation is therefore cancelled.

# b) Final Payment:

- i) Your \$80.00 per person deposit will be deducted from your total flight price should the West Coast Eagles qualify for the 2015 Toyota AFL Grand Final. At this point your Qantas airfare will be 100% confirmed.
- ii) Your outstanding balance will automatically be processed by a TASA staff member, as per the details on your PA form on Saturday 26<sup>th</sup> September 2015.

<u>IMPORTANT NOTE:</u> Please ensure you have sufficient funds available to cover the entire outstanding cost of your confirmed packages before the deduction date specified above.

# 4) Amendments - Changes by Us

a) It is unlikely Travel & Sports Australia will make changes to your booking, but we do plan the arrangements many months in advance and sometimes we may need to make changes which we reserve the right to do at any time. Most are very minor but where they are major (e.g. flights, hotels) we will inform you as soon as possible if you have already booked.

#### Cancellation and Refunds

- b) If you wish to make amendments in any way, your request must be received in writing. Changes to your booking will not be made until Travel & Sports Australia has received written notification from you.
